APPLICANT'S STATEMENT

The information provided by me in this application for employment is true and complete to the best of my knowledge, information or belief. Should I be employed by Pine Street Carpenters, any misrepresentations or false statement contained herein may be considered cause for dismissal or the withdrawal of an offer of employment.

Pine Street Carpenters, and its agents, have my permission to contact directly or employ the services of investigative agencies to obtain all necessary information from the references I have listed, or any other sources, concerning my prior employment, personal history, criminal background, education and credit standing, and I release all parties from any possible damages resulting from disclosing such information with or without prior written notice to me. In connection with these investigation or background checks, I acknowledge that Pine Street Carpenters may also require that I voluntarily provide fingerprints at the time of, or after, I sign this application.

I understand that if employed by Pine Street Carpenters, I agree that Pine Street Carpenters may exercise its right, without prior warning or notice, to conduct investigations of property, including, but not limited to, files, lockers, desks, vehicles, computers, and any of my personal property that I have on the premises of Pine Street Carpenters or its customers.

I understand and agree that if driving is a requirement of the position for which I am applying, or for which I am offered, my employment and/or continued employment is contingent on possessing a valid driver's license and automobile liability insurance in an amount equal to the minimum required by the state in which I reside. I also understand that if the position for which I am applying, or for which I am offered, requires manual labor and/or certain physical skills, Pine Street Carpenters may require that I submit to physical examination by a licensed physician. I understand that if a physical examination is required, my offer of employment is contingent upon acknowledgment from the physician that I am able to satisfactorily perform the essential functions of my prospective job duties. Pine Street Carpenters will pay for the cost of the physical examination.

I understand that Pine Street Carpenters, in an effort to maintain a drug-free workplace, requires all prospective employees to submit to a drug testing program.
